WHEREAS, Pima County ("County") and SER—Jobs for Progress of Southern Arizona, Inc., ("Contractor") have entered into a contract under which Contractor provides basic education services to support workforce development in Pima County; and

WHEREAS, the parties agree to extend the term and increase the funding of the Contract to continue services.

NOW, THEREFORE IT IS AGREED TO MODIFY CONTRACT AS FOLLOWS:

1. **ARTICLE I – TERM/EXTENSION, Paragraph A**, shall be deleted and replaced as follows:

This Contract, as awarded by County, shall commence on July 1, 2009, and shall terminate on June 30, 2011, unless sooner terminated or further extended pursuant to the provisions of this Contract. The County shall have the option to renew this Contract for up to one (1), 12-month periods or any portion thereof.

2. **ARTICLE III - COMPENSATION AND PAYMENT**, Paragraph A, shall be amended to increase the "not to exceed" amount to **\$315,000.00**.
