**THIRD AMENDMENT
TO LICENSE**
(CONTRACT No. 12-14-S-142320-0500)

THIS AMENDMENT is entered into by and between Pima County ("Licensor"), a political subdivision of the State of Arizona, and Sprint Spectrum, L.P., ("Licensee"), a Delaware Limited Partnership, and shall be retroactively effective May 26, 2009.

RECITALS

Licensor and Sprint Spectrum, L.P., a Delaware Limited Partnership, entered into a Non-Exclusive Right-of-Way Use License dated May 26, 2000, with expiration date of May 25, 2005, and recorded on June 08, 2000, in Docket 11315, Page 307, in the office of the Pima County, Arizona, Recorder.

The License was subsequently amended on two separate occasions. The First Amendment to License added location PH54XC607D, effective May 6, 2003 through May 25, 2005, and recorded on May 7, 2003 in Docket 12045, Page 1015, in the office of the Pima County, Arizona, Recorder. The License was amended a second time to adjust the fee schedule and extend the contract, effective May 26, 2005 through May 25, 2010, and recorded on July 3, 2006 in Docket 12838, Page 34, in the office of the Pima County, Arizona, Recorder.

Licensor formally ratified Licensee's right-of-way use license, as amended and as described above, on August 17, 2009, Resolution 2009-211. The license has been assigned Contract No. 12-14-S-142320-0500.

With this Third Amendment to License, the parties desire to amend the license to modify the site locations of Licensee's facilities and equipment (delete PH04XC251-A, Sunrise/Wilmot).




