**TUCSON-PIMA COUNTY HISTORICAL COMMISSION**

**PURPOSE:** To advise the governing bodies of the County and City of Tucson on historical activities and sites, and to organize historical activities for the community.

**AUTHORIZATION:** Pima County Ordinance No. 1995-90; and Pima County Resolution No. 1995-262; Joint - City/County.

**NUMBER OF MEMBERS:** 23 members, of which 10 shall represent Pima County, 12 the City of Tucson, and 1 the City of South Tucson. The membership of the Commission shall not be employees of the County, City of Tucson or City of South Tucson.

**APPOINTMENT DESIGNATION:** Supervisor Appointment unrestricted by district

**APPOINTMENT TERM:** The term of those members appointed by individual Board members of the Board of Supervisors shall be coterminous with that of the appointing elected official. Members of the Commission shall be eligible for reappointment but are in no way eligible to serve more than a total of eight (8) years.
