PURPOSE: Establish a Revolving Community Housing Trust Fund to resolve the following issues:

TRUST FUND

1. Realistic budget for first year of Housing portion of the Neighborhood Reinvestment Bond sale.
 2. Guide legal research on programmatic options.
 3. Review existing housing needs in stress areas.
 4. Design and Implementation of Public Outreach Process.
 5. Research other Community Housing Trust Fund operations.
- The committee will be required to meet as needed to establish in the early developmental stages with a formal structure to be recommended as part of the committee's charge.
 - The first priority will be to assist staff in designing a budget for this coming Bond sale and to recommend to the Board a yearly operational plan.
 - Monthly reports on committee activities will be provided to the Board of Supervisors at their monthly Study Sessions.

AUTHORIZATION: Board of Supervisors Action, April 21, 1998.
*Board of Supervisors Action, December 2, 2003,
approving a reduction in the size of the
committee from 21 members to 11 members.

NUMBER OF MEMBERS: *(11) Members to include Community Housing Advocates; Affordable Housing Providers; categorical appointments from technical fields with a history of Community Affordable Housing involvement.
