COMMITTEE STATUS: INACTIVE

PURPOSE: To confer with and advise the governing bodies of Pima County, City of Tucson, City of South Tucson and educational institutions on concerns to Urban Native American Affairs; and to serve in all capacities as detailed in Resolution No. 1989-30.

AUTHORIZATION: Pima County Resolution No. 1989-30.
Joint - City/County.

NUMBER OF MEMBERS: 22 members consisting of: 7 appointed by the Pima County Board of Supervisors, (5 supervisory and 2 at-large); 7 appointed by the Mayor and Council of the City of Tucson; 1 appointed by the Mayor and Council of the City of South Tucson; 1 appointed by the San Xavier Tribal Council of the Tohono O'Odham Nation; 1 appointed by the Pascua Yaqui Tribal Council; and 5 appointed by the Metropolitan Tucson Commission on Urban Native Affairs, to include representatives from education institutions, neighborhoods, etc.

APPOINTMENT DESIGNATION: Supervisor Appointment unrestricted by district

APPOINTMENT TERM: Commission members will serve four (4) years except for those members appointed by the Pima County Board of Supervisors and Mayor and Council of the City of Tucson. Terms of these members will be coterminous with the terms of the appointing Board member(s) or Mayor and Council Members of the City of Tucson. Members of the commission shall be eligible for reappointment but are in no way eligible to serve more than a total of eight years.
