INTERGOVERNMENTAL AGREEMENT FOR THE PROVISION AND
ADMINISTRATION OF CHILDHOOD IMMUNIZATIONS BETWEEN
SUNNYSIDE UNIFIED SCHOOL DISTRICT AND PIMA COUNTY

THIS AMENDMENT to that certain Intergovernmental Agreement by and between Pima County, a political subdivision of the State of Arizona, for and on behalf of the Pima County Health Department, hereinafter referred to as the "COUNTY", and Sunnyside Unified School District, a political subdivision of the State of Arizona, hereinafter referred to as "DISTRICT".

WHEREAS, the COUNTY and the DISTRICT have entered into an Intergovernmental Agreement in a joint effort to provide required childhood immunization services to the school children of Pima County at no charge; and

WHEREAS, the Intergovernmental Agreement contains a specific provision allowing the Parties to extend the Agreement for up to four additional one-year periods; and

NOW, THEREFORE, the following Amendment is agreed upon as follows:

Article I. Term – The Parties to this Intergovernmental Agreement exercise the option to extend the Agreement for a period of one (1) year, beginning February 16, 2013 and ending February 15, 2014.

All other provisions of the Intergovernmental Agreement, not specifically revised by this Amendment, remain unchanged.
