Tips and Rules

- ▲ **Solid waste generated outside of Pima County is not accepted.**
- ▲ Fees are payable in cash or check. No credit or debit cards accepted.
- ▲ All loads are subject to inspection by Pima County Solid Waste Management Division personnel.
- ▲ Bag it! Contain all waste in box or bag.
- ▲ Unsanitary waste (diapers, cat and dog waste) and other putrid waste must be bagged.
- ▲ Medical sharps must be in secured rigid container (coffee can with lid taped).
- ▲ Medications may be landfilled.
- ▲ Customers MAY NOT smoke at the landfill or transfer stations.
- ▲ Scavenging is NOT allowed at the landfill or transfer stations.
- ▲ Firearms, alcohol, or other controlled substances are NOT allowed on property.
- ▲ Follow all instructions of county personnel.
- ▲ Obey all signs.
- ▲ Drive carefully; watch out for heavy equipment.
- ▲ Keep children and pets in vehicles at all times.
- ▲ Pima County residents will not be charged for use of the Recycling Center or ABOP Collection.

Please Recycle These Items!

1. Newspapers
2. Brown Paper Bags
3. Corrugated Cardboard (remove plastic wrappers and flatten)
4. Paperboard (cereal and shoe boxes, remove plastic liners)
5. Milk Cartons and Drink Boxes
6. Molded Fiberboard
7. Magazines and Catalogs
8. Phonebooks
9. Printing and Writing Paper
10. Mail (envelope windows and labels ok, remove other non-paper items)
11. Other Paper (pamphlets, brochures, file folders, card stock, etc)
12. Plastic (PETE) Bottles (soda, water, etc. No trays or baskets)
13. Plastic (HDPE) Bottles and Jugs (Milk, water, juice, liquid detergent, shampoo, etc. No hazardous material containers)
14. Aluminum Cans
15. Steel/Tin Cans (non-hazardous aerosol cans are ok. No other steel)
16. Glass Food and Beverage Bottles and Jars. (no other glass)

Important Information

NO HAZARDOUS AND LIQUID WASTE ACCEPTED

Accepted Items for Landfilling

Items not hazardous or liquid including:

Bagged Household Waste, Green Waste, Construction Debris, Furniture and Carpet, Manure and Livestock Waste, Inert Materials such as Dirt, Rocks, Concrete, and Bricks.

Scrap Metal Bin – Residential Fees Apply

Residents may bring **scrap metal** including **household appliances** (washers, dryers, and hot water heaters). No fencing of any type. Refrigerators and other Freon containing items must be placed in special area (one per household per year (no commercial))

Note: The fee for scrap metal is the same as household garbage.

Tires – Limit of five with or without rims (one time per year). NO off-road tires. To dispose of more than five tires call 520.740.3340.

ABOP Collection

Antifreeze, Batteries, Oil, and Paint
(5 gallon maximum per month)
