



NOTICE OF INVITATION TO BID

SOLICITATION NO. 121885 - COUNTYWIDE OVERLAY SOUTH PROJECT

Sealed bids for construction of the COUNTYWIDE OVERLAY SOUTH PROJECT shall be delivered by the date and time indicated below to the Pima County Procurement Department offices located in the County Administration Building, 130 West Congress Street, 3rd Floor, Tucson, Arizona 85701. Bids must be accompanied by a surety bond of ten percent (10%) of the amount of the bid.

The project consists of installing 2" of AC overlay on segments of roadway in a variety of locations within Pima County. It also includes milling, re-stripping, replacing traffic legends, and replacing raised pavement markers as required.

Estimated cost for the project is \$2,000,000. The project shall be complete and in place within 90 working days from Notice to Proceed. Liquidated damages for late delivery will be assessed per Pima County Standard Specification Section 108-9.

Due to the limited scope of work, no goal for participation by Small Business Enterprises (SBE's) has been established for this project. However, contractors are encouraged to maximize the use of registered SBE's where possible.

The contractor must have the appropriate license issued by the State of Arizona Registrar of Contractors in order to bid and maintain same through the duration of the project. Your license's classification scope must cover all of the work you are planning to bid or perform whether you intend to perform the work with your own employees or if you intend to subcontract the work to others. Failure to have the appropriate license at the time of bid opening may result in rejection of the bid without further recourse and award of the contract to the next low responsive, responsible bidder. Pima County reserves the right to reject any and all bids or to withhold the award for any reason.
