



NOTICE OF INVITATION TO BID

SOLICITATION NO. 147853 - CAMINO VERDE: BRIGHTWATER WAY TO VALENCIA ROAD PROJECT

Sealed bids for construction of the CAMINO VERDE: BRIGHTWATER WAY TO VALENCIA ROAD shall be delivered at or before the date and time indicated below to the Pima County Procurement Department offices located in the County Administration Building, 130 West Congress Street, 3rd Floor, Tucson, Arizona 85701. Bids must be accompanied by a surety bond of ten percent (10%) of the amount of the bid.

The work consists of constructing a two lane collector roadway with a separate multi-use path along the Camino Verde alignment from Brightwater Way to Valencia Road. The total length of Camino Verde to be built under this project is approximately 0.5 miles. The work includes earthwork; furnishing and placing aggregate base and asphaltic concrete; constructing concrete headers, ford walls, and multi-use trail; pavement markings; traffic signal; installing landscaping and irrigation; and related incidental work.

Estimated cost for the project is between \$1,000,000.00 and \$1,500,000.00. The project shall be complete and in place within 90 working days from Notice to Proceed. Liquidated damages for late delivery will be assessed per Pima County Standard Specification Section 108-9.

A minimum goal of nine percent (9.00%) for participation by Small Business Enterprises (SBE's) as a percentage of the total amount of the bid award is established for this project. All bidders should read the SBE Documents carefully.

The contractor must have the appropriate license issued by the State of Arizona Registrar of Contractors in order to bid and maintain same through the duration of the project. Failure to have the appropriate license at the time of bid opening may result in rejection of the bid without further recourse and award of the contract to the next low responsive, responsible bidder. Pima County reserves the right to reject any and all bids or to withhold the award for any reason.
